

## **Conditions**

### **Stud Owner agrees to:**

1. To provide photocopy of stud's AKC registration.
2. Have the stud dog in good health.
3. Take proper care of the dam while in our care.
4. Provide the dam owner with written receipt for the stud service and a record of the breeding dates.
5. Sign litter registration promptly and return to dam owner.
6. Any other request to provide proof of shots, stool samples, etc., will also be provided.

### **Dam Owner agrees to:**

1. To provide photocopy of dam's AKC registration.
2. The dam must be in good physical condition confirmed by veterinarian.
3. The dam must have veterinary records to show proof of last check-up and to ensure she is up-to-date on vaccinations.
4. The dam must be free of ANY and ALL external and internal parasites (fleas, ticks, heartworm, worms, etc.).
5. The dam must have a stable temperament.
6. The dam must be between 2 years and not over 8 years of age.
7. Pay the agreed breeding fee and either the stud fee or puppy fee.
8. Notify the stud dog owner in writing no later than 70 days after mating if no pregnancy results from the mating.
9. The dam MUST have passed a Brucellosis test in the past 45 days.
10. The dam MUST have a parasite FREE stool sample done within the last 7 days.
11. The dam must have a genetic health test done either by DNA or through a qualified veterinarian, proof of results must be provided to the stud owner.

## **Stud Service Policy**

1. There is a \$300 NON-REFUNDABLE breeding fee.

2. Payment for stud services shall be rendered either by:

**Stud Fee-** Payment of \$\_\_\_\_\_. Half is due before the time of mating and is accepted as a full payment in the event that only ONE puppy is born or survived; the remaining balance is due when the puppies are three weeks of age.

**Puppy Fee-** The fee will be fulfilled by the first selection of a puppy from the resulting litter. If no puppy meets the needs of the stud owner, then the payment will result in using the Stud Fee amount.

3. All fees are only intended to cover the cost of the stud service and should not be taken as a guarantee of puppies. The dam's owner must notify the stud dog owner no later than 70 days after the last mating if the dam fails to whelp or whelps less than one surviving puppy at birth.

4. If the dam does not whelp a live puppy, the stud dog owner will return any payments, minus breeding fee.

5. Owner of the dam agrees to keep the dam confined and inaccessible to all other male dogs from the start of her heat cycle until the dam is fully out of heat.

6. Owner of the stud dog agrees to keep the dam to be bred confined and inaccessible to all other male dogs until the dam has been bred and returned to her owner.

7. Reasonable care will be given to the dam while in the possession of the stud dog owner. Any veterinary fees incurred during this time are the responsibility of the dam owner.

8. The dam owner agrees that all puppies resulting from this litter will be properly cared for and placed in the proper homes.

9. No puppy resulting from this breeding shall be transferred to wholesale outlets, dog dealers, brokers, humane shelters, laboratories, pet shops, or their agents.

10. It is expressly understood that the stud dog owner will not be compelled to sign the application for registration of this litter until the stud fee has been paid in full or until the stud dog owner takes custody of the puppy or pups as agreed. If any of the terms in this contract have not been met, or if the parentage of the resulting puppies is in doubt, the stud dog owner is not required to sign the litter application.
